## **2. TYPE OF DATA AND PURPOSE OF PROCESSING**

The Controller processes common data of the interested party such as: name, surname, telephone number, e-mail, social profiles, VAT Number, Tax Code and, if applicable, further personal data provided by the applicant in relation to the application procedure. The purpose of the processing is: 1) to promote the activities of **LATINA MATER** aimed at the organisation of the Competition; 2) to send notices, updates, information material of the event; 3) to inform the person concerned of all **LATINA MATER** initiatives.

## **3. LEGAL BASIS FOR PROCESSING**

The legal basis for data processing is the consent given by the applicant.

## **4. METHODS OF PROCESSING**

Data are acquired and processed on paper and/or through the use of electronic tools, by authorised and adequately trained employees and collaborators. The information is collected in compliance with the principle of "relevance and non-excessiveness" and the processing will be based on the principles of correctness, lawfulness, transparency and confidentiality.

## **5. DISCLOSURE AND TRANSFER OF DATA**

Participants' personal data will be communicated to their Partners, financial backers or sponsors of the event, to subjects involved in the organisation of the Competition or to subjects involved in the attribution of the photographic Works that will eventually be published, as provided for in the Rules of participation. The Data Controller does not transfer personal data to third countries, however it reserves the possibility of using cloud services and in this case the providers of such services will be selected from among those who provide adequate guarantees, as provided for in Article 4 of the GDPR (679/16).

## **6. LENGTH OF PROCESSING**

**LATINA MATER** shall keep personal data for the time strictly necessary to pursue the purposes for which they were collected or, in any case, for the period of time necessary to fulfil the duties established by the Rules for participation in the Competition and/or by current national regulations, by the European Union legal system or by international law.

## **7. RIGHTS OF THE DATA SUBJECT**

We inform you that as a data subject you have the right to exercise the rights set out in Articles 15,16,17,18,20 and 22 of G.D.P.R. 679/2016.

**Art. 15 - Right of access:** the data subject shall have the right to obtain from the Data Controller confirmation as to whether or not personal data relating to him are being processed and, if so, to obtain access to the personal data and information relating to the processing.

**Art. 16 - Right to rectification:** the data subject shall have the right to obtain from the Controller, without undue delay, the rectification of inaccurate personal data concerning him or her. Taking into account the purposes of the processing, the data subject shall have the right to obtain the integration of incomplete personal data, including by providing a supplementary declaration.

**Art. 17 - Right to erasure (right to be forgotten):** the data subject shall have the right to obtain from the Controller, without undue delay, the erasure of personal data concerning him or her. The Controller shall have the obligation to erase personal data without undue delay.

**Art. 18 - Right to restriction of processing:** the data subject shall have the right to obtain from the controller restriction of processing where one of the following applies: **a.** the accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data; **b.** the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead; **c.** the controller no longer needs the personal data for the purposes of the processing, but they are required by the data subject for the establishment, exercise or defence of legal claims; **d.** the data subject has objected to processing pursuant to art. 21 (1) pending the verification whether the legitimate grounds of the controller override those of the data subject.

**Art. 20 - Right to data portability:** the data subject shall have the right to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided. When exercising his or her rights regarding data portability, the data subject shall have the right to obtain the direct transmission of personal data from one controller to another, if technically possible.

**Art. 22 - Automated individual decision-making, including profiling:** the data subject shall have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning him or her or similarly significantly affects him or her.

## 8. WITHDRAWAL OF CONSENT

The data subject shall have the right to revoke his or her consent at any time. Revocation of consent shall not affect the lawfulness of the processing based on the consent before revocation.

## 9. RIGHT OF OBJECTION

As prescribed by Article 21 (4) of GDPR 679/2016, the data subject shall have the right to: object at any time, on grounds relating to his or her particular situation, to the processing of personal data concerning him or her pursuant to Article 6 (1) (e) or (f) of GDPR 679/2016. In this case, **LATINA MATER** shall refrain from further processing the personal data, unless there are compelling legitimate grounds for processing that override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.
