### **1. MODE OF COLLECTION OF PERSONAL DATA**

Personal data are provided voluntarily by the person concerned when applying to take part in the City of Latina International Photography Competition. Failure to provide such data will make it impossible to participate in the Competition, and withdrawal of consent to their processing will result in the exclusion of the person concerned from the event.

### **2. TYPE OF DATA AND PURPOSE OF PROCESSING**

The Data Controller processes common data of the data subject such as: name, surname, telephone number, e-mail, social media profiles, VAT number, and, where applicable, further personal data provided by the applicant in connection with the application procedure.

The purpose of the processing is: to promote the activities of **LATINA MATER ETS** aimed at the organisation of the Competition; to send notices, updates, information material on the event; to inform the person concerned of all **LATINA MATER ETS** initiatives.

### **3. LEGAL BASIS OF DATA PROCESSING**

The legal basis for data processing is represented by the consent given by the applicant.

### **4. METHODS OF PROCESSING**

The data are acquired and processed on paper and/or through the use of electronic instruments, by authorised and adequately trained employees and collaborators. The information is collected in compliance with the principle of "pertinence and non excess" and the processing will be based on the principles of correctness, lawfulness, transparency and confidentiality.

### **5. DISCLOSURE AND TRANSFER OF DATA**

Participants' personal data will be disclosed to their Partners, financial backers or sponsors of the event, to subjects taking part in the organisation of the Competition or to subjects involved in the attribution of the Photographic Artworks that may be published, as provided for in the Rules and Regulations.

The Data Controller does not transfer personal data to third countries, however it reserves the possibility of using cloud services and in that case the providers of such services will be selected from among those who provide adequate guarantees, as provided for in Article 4 of the GDPR (679/16).

## 6. DURATION OF PROCESSING

**LATINA MATER ETS** will keep personal data for the time strictly necessary to pursue the purposes for which they were collected or, in any case, for the period of time necessary to fulfil the duties established by the Competition Participation Regulations and/or by current national regulations, by the European Union legal system or by international law.

## 7. RIGHTS OF THE INTERESTED PARTY

We inform you that as an interested party you have the right to exercise the rights set out in articles 15, 16, 17, 18, 20 and 22 of the G.D.P. 679/2016.

**Art. 15 - Right of access:** the data subject has the right to obtain from the Data Controller confirmation as to whether or not personal data relating to them are being processed and, if so, to obtain access to the personal data and information relating to the processing.

**Art. 16 - Right of rectification:** the data subject has the right to obtain from the Controller, without undue delay, the rectification of inaccurate personal data concerning them. Bearing in mind the purposes of the processing, the data subject has the right to obtain the integration of incomplete personal data, including by providing a supplementary declaration.

**Art. 17 - Right to erasure (right to be forgotten):** the data subject has the right to obtain from the Controller, without undue delay, the erasure of personal data concerning them. The Data Controller is obliged to provide, without undue delay, for the erasure of the personal data of the data subject.

**Art. 18 - Right of restriction of processing:** the data subject has the right to obtain from the Data Controller the restriction of processing when one of the following cases occurs **(a)** the data subject contests the accuracy of the personal data, for the period necessary for the Data Controller to verify the accuracy of such personal data; **(b)** the processing is unlawful and the data subject objects to the erasure of the personal data and instead requests that its use be restricted **(c)** although the Data Controller no longer needs the personal data of the data subject for the purposes of the processing, the personal data are necessary for the establishment, exercise or defence of a legal claim; **(d)** the data subject has objected to the processing pursuant to Art. 21(1), pending verification of whether the legitimate reasons of the Data Controller prevail over those of the data subject.

**Art. 20 - Right to data portability:** the data subject has the right to receive, in a structured, commonly used and machine-readable format, personal data concerning them and has the right to have such data transmitted to another Data Controller without hindrance by the Data Controller to whom they have provided it. When exercising their rights in relation to data portability, the data subject has the right to obtain the direct transmission of personal data from one Data Controller to another, if technically possible.

**Art. 22 - Right not to be subject to automated decision-making, including profiling:** the data subject has the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning them or significantly affects them in a similar way.

The data subject is invited to bear in mind that the Data Controller may not be able to delete or limit the processing of data when processed for pharmacovigilance purposes due to legal obligations.

## 8. REVOCATION OF CONSENT

The data subject has the right to withdraw their consent at any time. Withdrawal of consent shall not affect the lawfulness of the processing based on the consent before withdrawal.

## 9. RIGHT TO OBJECT

As prescribed by Article 21(4) of GDPR 679/2016, the data subject has the right to: object at any time, on grounds relating to their particular situation, to the processing of personal data concerning them in accordance with Article 6(1)(e) or (f) of GDPR 679/2016. In this case, **LATINA MATER ETS** shall refrain from further processing the personal data, unless there are compelling legitimate grounds for processing that override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.
